# 2022 Schedule of Dues and Fees

All dues and fees are subject to increase without notice. Dues and non-refundable membership fees are subject to 6.5% FL sales tax.

## **Full Golf Membership**

\$35,000\* (Non-Refundable Initiation Fee)

Full Members are entitled to full use of the club and its facilities. Full Members have a seven day sign-up privilege to reserve golf tee times and five days to reserve tennis courts. Full Members shall not pay green fees or court fees, but shall pay golf cart & guest fees.

### Sports Membership

#### \$7,500 (Non-Refundable Initiation Fee)

Sports Member privileges will include use of the dining, pool, tennis, fitness and social facilities of the Club. Sports Members will also have the following golf privileges:

November 1<sup>st</sup> thru April 30th: Sports Members are allowed twelve (12) tee times during this 6 month period upon payment of daily sports green fees and cart fees. If a sports member is a guest of a golf member it is counted toward one of their (12) tee times. The driving range and practice facilities will be available to Sports Members on the days they have a scheduled tee time and after 1 p.m. on days without a tee time. Tee times may be made up to two days in advance during season.

May 1st – October 31st: Sports Members will have unlimited golf privileges upon payment of cart fee only. This includes the driving range and all practice facilities. Tee times may be made up to five days in advance during the off-season.

#### **Club Membership**

\$5,000 (Non-Refundable Initiation Fee)

Club Member privileges will include use of the dining, pool, tennis, fitness and social facilities of the club. Each Club Membership is allowed to play six (6) rounds per calendar year as a guest of a Golf or Sport Member.

### **Social Membership**

**\$1,500 (Non-Refundable Initiation Fee)** Social Member privileges will include use of the dining, social facilities and swimming pool at the club. This membership is mandatory for all Grandezza residents who do not have higher category of membership. 2022 Dues \$3,825.07
